**The basic job responsibilities include:**

- Legal research on U.S. law, international law, and other legal regimes
- Preparation of legal memorandums, court briefs, and filings for U.S. and other legal systems
- Work in collaboration with other NGOs and communities assist in the development of legal and advocacy strategies
- Research on new legal strategies to defend the human rights and environment of vulnerable communities
- **Communication of [organization's] work through web content and media contacts**
- **Policy advocacy with the U.S. legislative and executive branches**

**The Legal Fellow may also be asked to:**

- Travel domestically to court hearings, and appear in court on behalf of clients
- Travel internationally to meet with victims, communities, and NGOs
- Speak on behalf of [organization] in various venues
- Collaborate on [organization's] publications and assist in [organization] events
- Take initiative to develop and coordinate new projects
- Supervise law student interns on legal research projects

**Under the supervision of the Managing Attorney, the staff attorney will:**

- Maintain an appropriate caseload according to year of practice that includes complex advocacy and direct services;
- Develop case strategies and work plans for matters assigned;
- Draft pleadings, legal documents, trial memoranda, appellate briefs and **community education materials;**
- **Actively participate in community groups and coalitions on issues impacting service-eligible populations;**
- Investigate, develop and litigate high-impact cases at the trial and appellate level in federal and state courts;
- Negotiate case settlements, when appropriate;
- **Work on public policy issues impacting low income individuals and communities;**
- **Understand and ensure compliance with applicable program regulations and funding requirements.**



## Sample PD Exercise - Team Management\*

(\*provided by/adapted from PDSDC training exercise)

Tom, a junior attorney at a public interest organization, is assigned to work on a case with a team of other people – a social worker, an immigration attorney, and a housing attorney. Tom has been told that the social worker, who has been working in this area for a very long time, is excellent and knows her stuff. Tom is happy to leave the social work to her, since he has the legal aspects of the case to worry about, so after an initial team meeting Tom mostly manages the work of the other two attorneys on the case. Several months into the case, the client asks to meet with Tom and tells him that the social worker has been to his job site and has disclosed embarrassing information about the client's legal case. The client is very upset with Tom, as he is the team leader, and wants to know if Tom approved this action on the part of the social worker.

What went wrong here? What should Tom tell the client about what has happened to create this situation, and what will happen going forward? What conversation should Tom have with the social worker?

What skills might this exercise help a public interest lawyer develop?
