Membership Criteria and Limitations

Membership in NALP is institutionally based. Institutional members must be legal employers, ABA accredited law schools, or non-U.S. based law schools whose admission to membership is approved by the NALP Board of Directors. Employer members may include bar associations or nonprofit public interest organizations, government agencies, or any other employer whose active engagement in the recruitment of lawyers and law students is primarily for purposes of employment within its individual organization. Each institutional membership includes one (1) individual membership – referred to as the Primary (voting) member. Additional individuals at an institutional member may join as Associate Members for an additional fee. By applying for membership, you provide NALP with permission to email you about NALP products, events, research, industry news, and association updates.
