What are Peer Group Employment Outcome Reports?

The Peer Group Employment Outcome report consists of aggregated Class of 2019 ERSS data from 7-10 schools that you consider to be peers or with which you would like to compare your employment outcomes. The Peer Group Employment Outcome report looks like the National Summary report, but is based on just your chosen peer group, rather than all schools. In addition to the Peer Group Employment Outcome report, your package will include an Executive Summary, reporting selected measures for your school, your peer group, and the national figures. These reports are an important tool to discover the areas in which your law school is doing well in comparison to a group of like schools, as well as areas for improvement.

Can I choose more than one peer group?

Yes, you can select up to three peer groups.

Will individual law school data remain confidential?

Yes. Because the data on a peer group report will be the aggregated data from 7 to 10 other schools, it will be impossible to identify the employment outcomes data from any single school. These reports are not intended to be used to make or support public statements or assertions that compare one law school or another, or one law school with a group of law schools. How much does this report cost?
